Donna Bierer- opposed – wants 3000ft setbacks

Diane Brown - resident of Machias - owns land in Farmersville - wants 3000ft setbacks & 40dbl

Ginger Schroder – Resident of Farmersville – read letter from Amish community- submitted to board packet of emails to be entered in public record- wants 3000ft setbacks

Dan Mack- resident of Farmersville- wants 3000ft setback, 40dbl and law to protect welfare of citizens **Mark Heberling**- President of Farmersville United –Wants to keep the town beautiful, wants to see 3000 ft setbacks- submitted his statement to the lawyer

Lois Lane- resident of Farmersville since 1971 – all for the wind energy project – recommends the town board work on getting a good host agreement

Bill Snyder- lives on Rawson Rd- opposed to the wind energy project wants 3000ft setbacks – needs to be stricter law

Jon Rose – resident- is opposed to the project – doesn't want to look at them

Donna Vickman- resident & county legislator- tries to be neutral – made the resolution at the County level to protect all County residents- gave her letter to the lawyer

Dorothy Lockridge- resident- is opposed – law is not strict enough- also read a letter from a taxpayer that was opposed to the project- letter is in the packet Ginger presented

Millard Brown- resident – his farm has been in the family over 100yrs – is all for the wind energy project – doesn't see the setbacks as a problem

Jeanie McCarthy- resident- opposed to wind project- presented paperwork on Low Frequency noise and the medical issues with it

Butch George – taxpayer – all for wind project – town needs business- move forward not backward **Maureen Jessome**- taxpayer –owns 150 acres on Reynolds Rd – all for the wind project – money will help with the taxes and being able to keep the land for the grandkids

Mr. Hughes- resident – opposed to the wind project – people will move out of area if wind project come in

Jim Shannon- Freedom resident- approves of wind project, feels it will divide the community **Stephanie Morgan**- resident – opposed and wants to see 3000ft setbacks

Francis Lounsbury Jr- resident- opposed to project wants to see 3000ft setbacks, lower decimal, stricter law

George Duncan- resident- approves of wind project – suggested everyone do their homework and ask questions

Kathy Kellogg- resident- opposed to project- she asks the board for more days for written comments **Jasmine Killingbeck**- resident – opposed to project – family is avid hunters and worries it will hurt the hunting, wants 3000ft setbacks & 40 dbl

Dustin Bliss- taxpayer- approves of project – residents & town will benefit – make the best deal **Rob Mrowka** – Machias resident- oppose the project- benefits not passed on to everyone- wants 3000ft setbacks – ask the board to look into the environmental issues

Eric Miller- employee of Invenergy – 17 years on wind projects- real opportunity for tax cut **Mike Mulcahey**- employee of Invenergy – 11 years with wind projects- there are studies on property values & health studies-

Marv Covert – Centerville resident- approves of project- suggest people take tours of wind projects to see for themselves- respect your neighbors

Kevin Clapsadle – taxpayer- oppose the project – feels 50dbl is too loud

Laurie Fisher- Supervisor of Franklinville- opposes the project – feels there will be significant environmental impact

Denise Willard- Freedom resident – read a letter from taxpayer at 1379 Elton Rd opposing the project, also read another letter from another taxpayer opposing the project

Marjorie Osgood- read an email from Gerald Seiwert-resident that opposed the project

Dan Spitzer – lawyer for Invenergy- urge the residents to visit wind farms and find the facts

Aaron Saykyn- lawyer for Invenergy – is a safe project – need less setbacks – find the facts out

Adam Paul- read a letter from Russ Hatch – resident of Franklinville that opposes the project- wants 3000ft setbacks

Warren Harvey- from Chautauqua County- has been to Arkwright and there is 150 people that now want to sue the wind company- residents there have changed their mind

Karen Engstom- from Chautauqua County – advises to the board they need to vote down the wind project will be health issues

Randy Lester- Supervisor of Freedom- he had received an email from a resident opposing the wind project with a study attached —after further investigation realized the study was 13 years old and one of the writers had since withdrew his support- need to find the full facts out

Stephanie Milks- Freedom resident & from Freedom United- is a 15 year resident of Freedom wants further setbacks and read a letter from a Tracy Wood from Freedom who also opposes the project **Chuck Wright**- nonresident but family owns property on Reynolds Rd and he opposes the wind project **Albert Brown**- is a new resident on Rawson Rd and is opposed to the project —we need appropriate technology

Barry Miller – resident from Hinsdale- a licensed mechanical engineer – opposes the project – turbines Have low vibrations, turbines also fall down

Barb Dyskant – resident from Hinsdale- opposes the project – doesn't feel the area is suitable

Stewart Parks- moved from England 13 years ago cause of medical issues he had with wind turbine near his home

Penny Duncan- resident of Farmersville- came from Canada – there are thousands of turbines in Canada and areas have blossom cause of it

Tom Mchale – from labor union- there are 150 members locally and with this scope of project will bring construction jobs to the area

Jamie Lawerence- Opposes the project- has worked in the power industry- also read a letter from Susan Wood a supervisor in Hopkinton that wrote giving her experiences with wind energy project.

It was decided that the board would continue to accept responses for 14 days.

A motion was made to close the public hearing at 8:13pm by Mr. Westfall and seconded by Mrs. Tilton Roll call vote
