- SECTION 1. Whereas the Town Board believes that the intersection of County Road 80 otherwise known as Laidlaw Road and Pigeon Hill Road in the Town of Farmersville as presently marked and signed is a hazardous intersection. In order to protect the users of said highway the Town Board believes that it is appropriate to add an additional sign on Laidlaw Road in accordance with authority given to it by Section 1660 of the Vehicle and Traffic Law of the State of New York. Therefore be it enacted that,
  - On the easterly side of County Road 80, (also known as the Laidlaw Road) as it is proceeding northerly from State Route 98 towards its intersection with Pigeon Hill Road, that there be placed a "YIELD AHEAD" sign and a "YIELD" sign in accordance with the manual of Uniform Traffic Control Devices of the State of New York.
- SECTION 2. This Local Law shall become effective upon the filing thereof with the office of the Secretary of State.
