TITLE: Resolution Adopting Local Law 2 - 2021 "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW SECTION 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS WITHIN THE TOWN OF FARMERSVILLE"

WHEREAS, Pursuant to section 136 of the general municipal law and section 10 of the municipal home rule law, the Town of Farmersville may from time to time enact such local laws as it deems necessary; and

WHEREAS, proposed Local Law Local Number 2 of 2021 "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW SECTION 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS WITHIN THE TOWN OF FARMERSVILLE" was introduced by the Town Board; and

WHEREAS, a public hearing on said law was held on October 18, 2021 after being properly called and legally noticed, and

RESOLVED, that proposed Local Law Number 2 of 2021 "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW SECTION 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS WITHIN THE TOWN OF FARMERSVILLE" be and hereby is numbered in sequential number order and shall be known as Local Law Number 2 of 2021 as required by the New York State Department of State; and be it further

RESOLVED, that Local Law Number 2 of 2021 "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW SECTION 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS WITHIN THE TOWN OF FARMERSVILLE" as attached hereto is hereby adopted and that it take effect as provided by law for laws subject to permissive referendum. The Town Clerk is requested to so file said law with the Secretary of State.
